IMPORTANT: THIS IS A LEGAL DOCUMENT. BE SURE YOU READ AND UNDERSTAND THIS
DOCUMENT BEFORE SIGNING. ASSUMPTION OF RISK, WAIVER OF LIABILITY AND
INDEMNIFICATION AGREEMENT

As a member of The Ohio State University Ski Club (hereinafter "OSU Ski Club"), I understand that the activities of the OSU Ski Club including, without limitation, skiing, snowboarding, skydiving, rafting, camping, bicycling, and driving are dangerous activities and can result in serious injury and/or death and I participate in the OSU Ski Club activities at my own risk. I am fully aware of the risks and hazards connected with my participation in OSU Ski Club activities, and further understand that there may be risks and hazards unknown to me connected with my participation in OSU Ski Club activities. I hereby elect freely and voluntarily to participate in OSU Ski Club activities with the knowledge of the danger involved and hereby freely and voluntarily agree to assume and accept any and all risk of illness, injury or death.

In consideration for receiving permission to participate in OSU Ski Club activities, I understand, acknowledge and agree as follows:

1. The OSU Ski Club is not an insurer of my behavior, actions or participation in its activities. The OSU Ski Club assumes no liability whatsoever for personal injuries and/or death to me or to third persons arising out of my participation in OSU Ski Club's activities including, without limitation, injuries and/or death incurred in transit to or from OSU Ski Club activities or in any other place reasonably connected with OSU Ski Club activities. Further, the OSU Ski Club assumes no liability for property damage with respect to me or any third-party arising out of my participation in the OSU Ski Club's activities or occurring while in transit to or from such activities, or in any place reasonably connected to such activities;

2. I hereby release, waive, discharge and covenant not to sue The Ohio State University, the OSU Ski Club and all of their respective officers, servants, members, employees, agents and trustees (collectively, the "Released Parties") from and against any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or loss or damage to my property or to any third party arising out of or related to my participation in OSU Ski Club activities, including, without limitation, injuries and/or death incurred in transit to or from OSU Ski Club activities or in any place reasonably connected to such activities;

3. I further agree to indemnify and save and hold harmless the Released Parties from any loss, liability, damage or costs they may incur due to my participation in OSU Ski Club activities including, without limitation, transit to or from OSU Ski Club activities or at any place reasonably connected to such activities;

4. As a member of the OSU Ski Club, I further understand that I am responsible for following and abiding by all of The Ohio State University's rules and regulations relating to student conduct while I participate in activities of the OSU Ski Club. Specifically, I understand The Ohio State University does not permit the consumption of alcohol by a student under the age of twenty-one (21), and, as such, consumption of alcohol by an OSU Ski Club member under the age of twenty- one (21) shall be a violation of The Ohio State University's rules and regulations relating to student conduct. I further specifically agree to indemnify and save and hold harmless the Released Parties from any loss, liability, damage or costs they may incur as a result of my violation of the law and/or The Ohio State University's rules and regulations prohibiting consumption of alcohol by a student under the age of twenty-one (21).

5. I shall pay any attorney's fees or costs incurred by the Released Parties in enforcing this Agreement;

6. This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio, without application of any principles of choice of law;

7. Any action or proceeding arising out of or relating to this Agreement may only be brought in the courts of the State of Ohio, County of Franklin, or, if it has or can acquire jurisdiction, in the United States District Court for the Southern District of Ohio;

8. If any portion of this Agreement is held to be invalid by a court of competent jurisdiction, then it is agreed and intended that the remainder of this Agreement shall, nevertheless, continue in *full* force and effect;

9. This Agreement shall bind my heirs and personal representatives.

In signing this release, I acknowledge and represent that:

- I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed; No oral representation, statements or inducements, apart from the foregoing written Agreement have been made;
- I am at least eighteen (18) years of age and *fully* competent; and I execute this release for full, adequate and complete consideration fully intending to be bound by the same.
